PROPOSED PLYMOUTH-GREEN DEVELOPMENT GOES BEFORE THE PLANNING COMMISSION ON OCTOBER 6

The open, green space on the Northwest corner of Plymouth and Green could be dramatically altered by a proposed commercial and residential development. Updated plans for a dense, multi-use project with 5 buildings, 35 condos, a bank, a restaurant, office and retail space, 264 parking spaces and another curb cut onto Plymouth Rd (between Commonwealth and Green) will be considered by the Planning Commission in October.

The density of this project, the traffic it will generate, and the changes in traffic patterns it will produce along with its affect on the wetland on the corner are all of potential concern for our residents. For this project to be approved this property must be rezoned. Project details and the process that will be necessary for it to gain approval can be found on our website **www.ohmha.org**.

The Planning Commission will hold a public hearing on this project Thursday October the 6th at City at 7:00 pm in Council Chambers, City Hall.
